

IMMIGRATION ATTORNEY RESOURCES

This handout provides information for international students and scholars who are starting the search for an immigration attorney (lawyer). However, *the Office of International Services does not endorse one attorney over another and this list is not a recommendation of attorneys.** Lawyers in the US are specialized, including immigration attorneys. You will want to ask them about their areas of specialization (family law, employment law, asylum, etc.) to see if they are a good fit for your situation. If a student has had an arrest or other type of legal situation, it is strongly recommended that they speak with an immigration attorney **and** a criminal attorney for best results.
